Application Instructions for The Magnolia Lighting Award 2019

All applicants shall carefully read and understand the provisions of the Application Instructions, and be responsible for its own application and rights: 1, the applicant shall ensure that the information is completed in a true and valid manner, and submit online information and send physical products (for product category awards) to the Magnolia Lighting Award Office (overdue).

- 2, All application information can be modified or supplement before audit and passed; once the system audit passed, the applicant cannot do any modification or adjustion. So please fill in with caution.
- 3, The organizer will charge application fee according to the number of applicant projects and products:
- 1) online information submit time 1: Jun. 10th Aug. 25th (¥ 500 per item)
- 2) online information submit time 2: Aug. 26th Oct. 7th (¥1000 per item)
- 4, application fee payment deadline: Oct. 7th 24: 00.
- 5, Once submitted, the application fee cannot be refundable.
- 6, The organizing committee will notify the projects that pass the pre-trial immediately via mail or phone; there will be no furthur notice to those eliminated.
- 7, All materials submitted are required to be in Chinese version (before September 10), and if the materials need translation from the organizing committee, an extra translation fee will be charged depending on the information (RMB): Y 500 per thousand Chinese characters.
- 8, Any Chinese materials submitted beyond the deadline will be deemed to be automatically abandoning the application.
- 9, Design works should be in forms of electronic materials; while product works, in addition to filling in electronic materials, shall also send samples of the entries to the award office (postage out).

- 10, The project photos and product drawings submitted by the applicants shall reflect the original appearance of the projects and the products, and shall not be processed and modified in the lighting effect.
- 11, Those who over-decorated the submitted pictures will be publicly warned by organizing committee;
- 12, The delivery time and place of all the products are still to be determined. The organizing committee will inform the applicant immediately after confirming the delivery time and place of the products.
- 13, If the product shipping or field visit is not available within the prescribed time for the reasons of the applicants, the Organizing Committee will not be liable.
- 14, Applicants shall bear the risks and costs of the product/display in transit. Therefore, applicants are advised to insure their products/displays on transport insurance.
- 15, The products will be retrieved after the awards ceremony. The date and details of the retrieval will be announced by the Organizing Committee by mail/telephone. Please keep in noticed.
- 16, The Organizing Committee take the responsibility for the custody of the submitted products during the examination period (pre-trial and final). Here we recommends again that the applicants sign the transportation or logistics insurance contracts and insure against possible damages or theft during transit.
- 17, The submitted products, whether during the selection or the awards ceremony, is subject to the general use and wear of the product by the review and guest or caused by the use of the product, and in this case, the Organizing Committee shall not be liable for damages. 18, The applicant shall ensure the authenticity of the project information submitted, obtain the permission of the relevant parties to the project. The responsibility shall be borne by the applicant if any interest of other parties were affected after publication. If the Organizing Committee receives any report of false or controversial information about the applicants, the Organizing Committee shall have the right to disqualify the applicants or reclaim the awards after verification and confirmation.

- 19, If the reporting party shall ensure that it has the intellectual property rights related to the contest, and if the organizing committee suffers losses due to the infringement of the legitimate rights and interests of any third party, etc., the award organizing committee shall have the right to hold the participating party liable for the relevant liability.
- 20, The copyright of the materials submitted shall be jointly owned by the organizing committee and the applicant, and the organizing committee shall have the right to re-produce and re-publicize the information submitted by all applicants without compensation.
- 21, The applicants agree that the organizing committee shall use the entries, designer's name and other necessary information in public voting, award announcements, folios, exhibitions, media advertisements, etc.
- 22, The applicants agree that the organizing committee shall have the right to apply the pictures and text of its participating items in any way to the website, printing materials, advertising materials for publicity and other purposes related to this activity, and shall no longer pay compensation separately, and the above rights shall not be restricted by geographical restrictions.
- 23, If the applicants do not wish to publish or distribute images and text materials, they shall send an e-mail request to baiyulan@elegence.net to notify the organizing committee, which shall take effect since the time the request is received.
- 24, The information submitted by the applicants will only be used to the extent necessary to deal with matters relating to this activity and will not be disclosed to third parties without the consent of the applicants.
- 25, If necessary, the applicant must provide a letter of recommendation (stamped with a seal) from the relevant units to avoid unnecessary product/project property disputes.
- 26, After the judging process, the organizing committee will notify the winning parties by e-mail and telephone.

27, Joint application units shall have the right to receive the trophies and certificates simultaneously after being notified of the award.

- 28, If the winning unit is absent from the award ceremony for no reason, they will be deemed to be automatically giving up the award.
- 29, The number and names of the joint application units shall be based on the submitted materials; once the submission is confirmed after deadline, the organizing committee will not accept any modification or deletion due to the reasons of the application units. If it harms the image and interests of the award, the organizing committee shall have the right to cancel the qualification of the project.
- 30, The winning parties will be awarded trophies and certificates by Shanghai Illuminating Engineering Society.
- 31, The Organizing Committee shall not be liable for the evaluation work caused by the force majeure incident.
- 32, Upon registration and during the entry period, the declaring party shall notify the Organizing Committee when a third party claims rights to the products/items that are about to be registered or have been registered, in the event of an inquiry letter, warning letter, legal action or similar procedure.
- 33, If there is any objection to this notice and the matters relating to the 2019 Magnolia Lighting Award, the organizing committee reserves the right to final interpretation, and any matters relating to this award shall be further ruled and interpreted by the organizers.
